- Suppliers shall not discriminate against workers or job seekers on the basis of gender, age, marital or maternity status, ethnicity, colour, religion, sexual orientation, native place, domicile, nationality, party affiliation, educational background, or other similar factors.
- Suppliers must enter into employment contracts with all employees that meet local legal requirements, pay employees at or above the local statutory minimum levels, and pay employees on time.
- Overtime labour must be compensated in accordance with local regulations, and overtime work must not exceed the statutory working hour limit.
- Suppliers must adopt proper occupational health and safety standards and procedures to reduce occupational injuries and illnesses, as well as policies to protect employees' rights and interests, as well as their health and safety.
- Suppliers must implement appropriate communication channels and grievance processes so that workers may express their issues to the supplier's management.
- Suppliers must use proper risk management strategies and preventative actions to avert disasters in environmental and labour management as much as possible.
