

लोकसभा में उठा चांदीपुरा विषाणु के प्रकोप का मुहा नई दिल्ली, 24 जुलाई (ब्यूरो)।

गुजरात में चांदीपुरा विषाणु से अब तक 37 बच्चों की मौत होने का दावा करते हुए कांग्रेस की सांसद गनीबेन नगाजी ठाकोर ने केंद्र सरकार से इस विषाणु के संक्रमण को फैलने से रोकने के लिए जल्द से जल्द सख्त कदम उठाने की मांग। उन्होंने कहा कि इसे गंभीरता से नहीं लिया गया तो दोबारा कोरोना महामारी जैसी भयानक स्थिति पैदा हो सकती है।

ठाकोर ने लोकसभा में श्रून्यकाल के दौरान इस मुद्दे को उठाते हुए कहा कि मेरे संसदीय क्षेत्र बनासकांठा समेत पूरे गुजरात में इस समय चांदीपुरा विषाण का संक्रमण खतरनाक रूप लेता जा रहा है। गुजरात के अलग-अलग जिलों में अब तक 84 मामले इस विषाण् के संक्रमण के आ चुके हैं। इससे अब तक 37 बच्चों की जान जा चुकी है। उन्होंने कहा कि आंकड़ों को देखें तो ऐसा लगता है कि इस विषाणु से संक्रमित 100 में से केवल 15 फीसद मरीजों को ही बचाया जा सकता है। गुजरात के अहमदाबाद, वड़ोदरा, सूरत और विरोध का सामना कर रही है। भाजपा नेता और पूर्व बनासकांठा समेत अधिकतर जिलों में इस विषाण का प्रकोप देखने को मिल रहा है जो दिन प्रतिदिन घातक खासकर कांग्रेस नेता राहुल गांधी पर निशाना साधा और होता जा रहा है और अधिकतर बच्चों को अपना शिकार बना रहा है। कांग्रेस सांसद ने कहा कि इस पर बदनाम करने का आरोप लगाया। प्रसाद ने कहा कि विषाणु को गंभीरता से नहीं लिया गया तो दोबारा कोरोना महामारी जैसी भयानक स्थिति पैदा हो सकती है। उन्होंने प्रधानमंत्री और स्वास्थ्य मंत्री से आग्रह गांधी द्वारा बजट को 'कुर्सी बचाओ बजट' करार दिए किया कि गुजरात में तेजी से प्रकोप दिखा रहे इस विषाणु को गंभीरता से लेते हुए इसकी रोकथाम के लिए जल्द से जल्द कठोर कदम उठाए जाएं।

देवेगौड़ा के विशेष उल्लेख पर विपक्षी सदस्यों ने जताई आपत्ति

नई दिल्ली, 24 जुलाई (ब्यूरो)।

राज्यसभा में बुधवार को उस समय असहज स्थिति उत्पन्न हो गई जब विशेष उल्लेख के जरिये पूर्व प्रधानमंत्री एवं जद (सेकु) प्रमुख एचडी देवेगौड़ा ने एक मुद्दा उठाया और विपक्षी दलों के सदस्यों ने उनके कुछ शब्दों को लिखित प्रारूप से अलग तथा असंसदीय बताते हुए आपत्ति जताई।

देवेगौडा ने विशेष उल्लेख के जरिए कर्नाटक. उसके आसपास के राज्यों और देश के विभिन्न भागों में प्राकृतिक आपदा की वजह से उत्पन्न परेशानी का मुद्दा उठाया। उन्होंने कहा कि प्राकृतिक आपदा की वजह से कर्नाटक में जान माल का बड़ा नुकसान हुआ और सरकार या किसी मंत्री ने राज्य का दौरा

नहीं किया। वह किसी पर आरोप नहीं लगा रहे हैं किंतु राजनीति एक अलग मुद्दा है और गठबंधन भी होते हैं लेकिन संकट की स्थिति अलग होती है।

उन्होंने 'लोगों की जान गई, राज्य सरकार क्या कर रही थी?' देवेगौडा के विशेष उल्लेख के बाद विपक्षी सदस्यों ने उनके वक्तव्य को विशेष उल्लेख के लिखित प्रारूप से अलग तथा असंसदीय बताते हुए आपत्ति जताई तथा आसन से मांग की कि जो हिस्सा लिखित प्रारूप से अलग था उसे कार्यवाही से हटाया जाए। कुछ सदस्यों ने कहा कि सदन में सबके लिए एक समान व्यवस्था होनी चाहिए। देवेगौड़ा ने कहा कि उन्होंने कुछ भी असंसदीय नहीं कहा है। सभापति जगदीप धनखड ने सदस्यों को शांत करते हए कहा कि देवेगौडा पूर्व प्रधानमंत्री हैं।
