

Dear Sir,

I, Tejinder Parkash, Practicing Chartered Accountant having office at SCO-20, Sector 20D, Tribune Road, Chandigarh (U.T.) - 160020, appointed as Scrutinizer for the purpose of scrutinizing the polling done on the resolution as mentioned below, entailing the Scheme of Amalgamation of Shriram Automotive Products Limited and Shriram Pistons & Rings Limited("Scheme") under Sections 230 to 232 of the Companies Act, 2013 and their respective Equity Shareholders at the Meeting, submit my report as under:

1. In terms of the directions contained in the Order dated 03.10.2018, passed by the Hon'ble National Company Law Tribunal, Principal Bench at New Delhi ("NCLT"), the quorum for the Meeting was fixed as 500 equity shareholders. Further, it was directed that if the aforesaid quorum for the Meeting is not present, then the Meeting shall be adjourned by 30 minutes and thereafter, the equity shareholders, present and voting, shall be deemed to constitute the quorum.

- The Chairperson commenced the Meeting at 11:00 A.M., however, due to the absence of the
  requisite quorum, the Meeting was adjourned by 30 minutes in terms of the said Order and was
  thereafter, reconvened at 11:30 A.M.
- 3. Original Ballot papers duly signed by the Chairman and Alternate Chairperson were handed over to the equity shareholders or to the authorized representatives along with proxy holder(s) of equity shareholders to cast their votes. After the Chairperson ordered the voting on poll, I had demonstrated the Ballot Box in the presence of voters, who unanimously confirmed that the Ballot Box is empty, locked the Ballot Box in the presence of the Members, who were present in the meeting hall.
- 4. The Chairman asked all members, authorized representative and proxy holders to cast their votes. The Members then cast their votes one by one. Once the voting by all the Members was completed, I had obtained permission of the Chairperson to unlock the ballot box in the presence of following two witnesses (Public Shareholders): (i) Mr. Harmohan Singh Sawhney r/o 11/24AB T. Nagar, New Delhi 110018 and (ii) Mr. Praveen Kumar, 5036, Gali, Dirogschslu Singh, Pshli-Dlti Raj, Delhi 110006. I had checked and verified that Ballot Papers put in Ballot Box by the voters were only those which were signed and numbered by me. Thereafter, all the Ballot papers were placed before the Chairperson and the Alternate Chairperson and the same were scrutinized.
- 5. All Postal Ballot forms received up to 18.11.2018 at 05:00 P.M. (IST), the last date and time fixed by the Transferee Company for receipt of the forms were considered for my scrutiny. The postal Ballot papers were duly opened in my presence and the same were arranged and diligently scrutinized.
- The voting was also done by e-voting in terms of the order as per Companies Act, 2013 and rules
  made thereunder. The data as retrieved from the depository, CDSL has been taken out and the
  result of the same has also been collated.
- 7. On 21st November, 2018 after counting of the votes cast by equity shareholders at the venue of Meeting, the votes cast through remote e-voting facility was duly unblocked by me at about 12:02 P.M as a Scrutinizer in the presence of two witnesses, (i) Mr. Rajesh Gupta r/o House No.94, Sector 16, Panchkula, Haryana 134019 and (ii) Mr. Prince Chadha r/o # 48/Sector 41-A, Chandigarh 160036 who acted as the witnesses.

- 8. The poll paper, which was found defective have been treated as invalid and kept separately.
- The following resolution to approve the Scheme of Amalgamation of Shriram Automotive Products Limited (Transferor Company) with Shriram Pistons and Rings Limited (Transferee Company) was put to vote.

(NSE) and subject to the provisions of the Memorandum and Articles of Association of the Transferee Company and subject to the approval of Hon'ble National Company Law Tribunal, Principal Bench at New Delhi ("NCLT") and subject to such other approval(s), permission(s) and sanction(s) of regulatory and other authorities, as may be necessary and subject to such conditions and modifications as may be prescribed or imposed by NCLT or by any regulatory or other authorities, while granting such consents, approvals and permissions, which may be agreed to by the Board of Directors of the Transferee Company (hereinafter referred to as the "Board", which term shall be deemed to mean and include one or more Committee(s) constituted/to be constituted by the Board or any person(s) which the Board may nominate to exercise its powers including the powers conferred by this resolution), the arrangement embodied in the Scheme of Amalgamation of Shriram Automotive Products Limited (hereinafter referred as Transferor Company) with Shriram Pistons & Rings Limited (hereinafter referred as Transferee Company) and their respective shareholders and creditors ("Scheme") placed before this meeting and initialed by the Chairman of the Meeting for the purpose of identification, be and is hereby approved.
