- d) Respect for Human Rights, Diversity & Inclusion: Provide a safe, inclusive workplace free from discrimination, harassment, and forced labour.
- e) Anti-Bribery & Corruption: Prohibit any form of bribery, kickbacks, or unethical inducements.
- f) Environmental Responsibility & Sustainability: Minimize environmental impact by adopting sustainable sourcing, waste reduction, and responsible energy use.
- g) Digital Ethics & Data Privacy: Protect company and stakeholder data, ensure cybersecurity best practices, and prevent unauthorized access to information.
- h) Health & Safety Commitment: Maintain workplace safety standards, provide necessary training, and comply with all occupational health regulations.
- i) Whistleblower Protection & Non-Retaliation: Encourage the reporting of unethical behaviour and ensure protection against retaliation.
