Textual Information(1)	As on Q.E. June 30, 2025: 1. Luv D. Shriram and Meenakshi Dass jointly held 60,07,362 (13.64%) shares as Trustees of Deepak Shriram Family Benefit Trust(DSFBT). Luv D. Shriram also holds 10,900 (0.02%) shares in his name. Accordingly, his shareholding as Trustee of DSFBT and his individual shareholding was consolidated on Luv D. Shriram's PAN Basis i.e. ABBPS9860J as 60,18,262 shares in consonance with the Register of members. 2. Meenakshi Dass and Luv D. Shriram jointly held 60,07,362 (13.64%) shares as Trustees of DSFBT. Meenakshi Dass also holds 16,69,440 (3.79%) shares in her name. Accordingly, her shareholding as Trustee of DSFBT and her individual shareholding was consolidated on Meenakshi Dass's PAN Basis i.e. AAJPD9324P as 76,76,802 shares in consonance with the Register of members. However, during the Q.E. September 30, 2025, the shareholding of DSFBT (60,07,362 + 60,07,362 = 1,20,14,724 shares) held through its trustees i.e. Luv D. Shriram and Meenakshi Dass jointly, has now been consolidated under its own PAN i.e. AAATD6816B. The register of members has been updated accordingly. There is no change in their individual shareholdings and same have been mentioned against their respective PANs.
